3. June community consultation response; identifying key themes and filling in the Consultation Statement

- Rick Noordegraf has collated the data into themes ready for summarising in the Consultation Statement. The purpose of this data is to provide information to use towards deciding the KNDP policies and for contributing to the evidence base to support the policy decisions for the KNDP. This June Consultation data is purely qualitative and not fully representative and can only be used in conjunction with the more robust Parish plan data and other considerations when formulating policy. Possible sites were looked at for village amenities such as a pre-school, which could be allocated outside any development boundary for housing. There would have to be a transparent call for sites if this is agreed. It was agreed that more walks are needed to include Shirlheath and to identify spaces that we would like to protect from development.
